

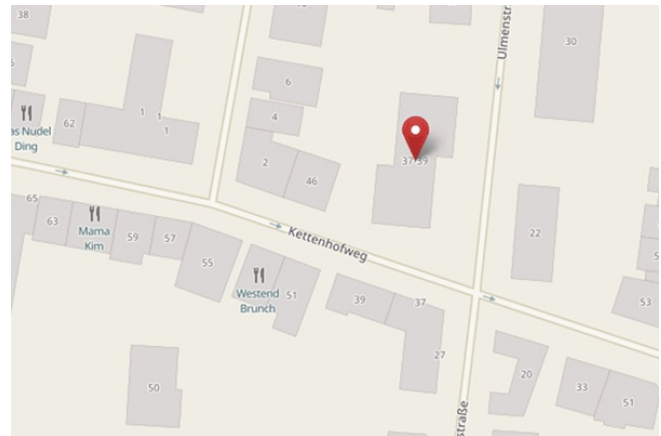

Arriving by car

motorway A 5/A 648 - towards Stadtmitte (city centre). Turn off at the Ludwig-Erhard-Anlage (a large roundabout), towards Hanau until Bockenheimer Warte. Turn right onto Bockenheimer Landstraße. After ca. 600 m turn right again onto Ulmenstraße.

or

motorway A 5 / A 66 - exit no. 21 Miquelallee towards F-Eschersheim / F-Ginnheim / Nordweststadt, then keep to the right towards Messe/Universität/Hauptbahnhof, follow the main road B8, after about 1 km turn left (Bockenheimer Landstraße), after about 600 meters turn left onto Ulmenstraße

You will find us in the **high-rise towers "Romeo und Julia"** (ca. 100 meters further on the right hand side). Visitors' parking places are available.

Arriving by public transport

Subway lines U6/U7: Exit at Alte Oper, then continue on foot via Kettenhofweg to Ulmenstraße. Turn right, and our office will be on the left.

City train lines S1 through S9: Exit at Taunusanlage. Go north on Mainzer Landstraße/Taunusanlage to Guiollettstraße. After about 300 meters turn right onto Ulmenstraße. Our office will be on the left after about 150 meters.
